INFORMED CONSENT/GENERAL RELEASE AND AUTHORIZATION Waiver of Liability and Release For for Prospective and/or Returning Burlington Blast Fastpitch Softball Players:

I, the undersigned participant/parent or guardian of the participant, recognize and acknowledge that participation in the Burlington Blast Softball Program and use of any batting cage, practice facility and/or team equipment involves risk of serious injury, including permanent disability or death, illness and severe social and economic losses which might result from participant action inaction, negligence of others, rules of play, or the condition of the premises or any equipment use thereon. Further I understand that there may be other risks not known or reasonably foreseeable at this time and that such risks shall be assumed by the undersigned.

In my absence, I authorize Burlington Blast Softball Program and its agents or assigns to call for emergency rescue services for my daughter should they be necessary in the case of injury or suspected injury, illness or during the times that the above named individual is participating in an activity sponsored by the Burlington Blast Softball Program. I will accept responsibility for the payment of any and all treatment provided therein including emergency rescue services.

I certify that the above named is capable of participating safely in the Burlington Blast Softball Program. If I observe any significant change in my child's readiness for participation in the program, I will remove my child immediately. I understand that the Burlington Blast Softball Program does not provide accident, health, or life insurance coverage for the above participant during participation. I further understand that I am legally responsible for actions of the above named individual including, but not limited to, any damage to private or public property. I am legally responsible for my own and/or my child's welfare and actions including personal needs and medical expenses.

I agree to indemnify and hold the Burlington Blast Softball Program, its officers, agents, consultants and representatives harmless from any loss, damage, illness or injury which may result from my or my child's participation in activities sponsored by the Burlington Blast Softball Program. For the good and valuable consideration of my child participating in the Burlington Blast Softball Program, I agree to release, waive and discharge, and covenant not to sue the Burlington Blast Softball Program, its officers, agents, consultants, and representatives for any claims, demands, or actions whatsoever arising out of any damage, loss, or injury incurred on or to me or my child as a result of my participation or my child's activities sponsored by the Burlington Blast Softball Program. This release of liability and indemnity applies to me, the undersigned, or my child, as well as any personal representatives, assigns, heirs and next of kin.

I have read and fully understand the effect of the relinquishment of the rights that I hereby waive. I have considered that if this waiver of liability was not as broad as it is, the cost for my use of the facility would be considerably higher and, as I do not wish to pay a considerably higher cost, I waive the right to bargain for different waiver of liability terms.
